


Welcome back fellow residents of White City, and those reading from the surrounding area, for the May 2022 edition of the White City Councillor Blog.

The White City Fire Department (WCFD) is the focus for this month's blog. WCFD serves White City, Emerald Park and the surrounding region, it is made up of dedicated men and women that are our neighbours, local business owners, and/or community leaders that will respond to any emergency day or night. The value that a highly trained and professional fire department brings to any community is immeasurable and a service you never want to call on but are happy and safe knowing it is there for you.

WCFD responds to approximately 150 calls for service per year, this includes fire and medical response:

This certification is a professional designation recognized provincially and internationally with standards used in career fire departments. 

The department has been growing, expanding and serving the broader community over the past 40 years and has grown into a thriving, well trained, well equipped and prepared service provider in our community. It takes many years of hard work, teamwork, preparedness and training to reach the level of dedication and expertise we are lucky to have in our local fire department.
